1. Minutes of 2009 AGM

2. Matters Arising

4. Proposed changes to constitution

1st proposed change:

In section 4, second paragraph, change

to

'No officer may serve in the same role for more than three consecutive terms, but they may be nominated again after one year has passed.'

This change was accepted by all, with the proviso that Monica looks at the constitution and brings any new proposal to the committee to discuss in time for the 2011 AGM.

2nd proposed change:

In section 5.1, delete 'Nominations for members of the Committee and Officers of FCHB must be received by the Secretary at least a fortnight in advance of the AGM.'.

This was not accepted, so no change

3rd proposed change:

In section 7, delete 'Proposals for any amendment to this constitution must be submitted to the Committee for approval'.

This was not accepted, so no change
