The proposed interpretation boards are progressing. Monica confirmed that the design had been agreed in February – a copy was circulated to the group. The City Council will be producing and paying for the boards – they are currently consulting with the design agency. The two boards are hoped to be installed soon, one at Burnside junction and the other at the Dawes lane bridges.

The boards are supposed to be vandal proof. Simon Bunn commented that whilst the council made every effort to make vandalism difficult it was not always possible to prevent it.

It was confirmed that a botanical survey had been completed in the past to inform the board.

It was queried whether the north point on the map actually pointed north – Monica will check this and liaise with the Council.

The consultation with Sainsbury's has not been effective and needs more work, no progress has been made in the past year. Sainsbury's are unwilling to enter into any correspondence and there has been no response from the General Manager. The Sustainability section of Sainsbury's website could be targeted but hasn't been yet.

Simon Bunn commented that the Council have not had much success either. The council have met with landscape architect at the brook and discussed protection of the area. Sainsbury's have a legal responsibility to maintain the condition of the water in the brook under the system of 'riparian rights'. The Council have responsibility for the path and shared responsibility for the waterway. Simon intends to write another letter from the City Council to Sainsbury's outlining their responsibilities, John noted that FoCHB would offer any support as necessary.

Phil suggested asking local councillors to support the cause.

After representation to the Council, toad kerbs have been installed on the pavements.

The new website is now active and Jón Faibairn is the webmaster.

There has been no outcome to the consultation of whether Burnside should be included in the conservation area. Simon said the Committee would not sit until June  $21^{st}$ .

The CNHS 'Converzatione' exhibition will be held on 17/18 June. Monica has booked a stall for FoCHB at the event and helpers are welcome to man the stall. The information posters were displayed for members.

Merlin offered to circulate the event details to members of Cambridge Conservation Volunteers.
