#### **2014 Activities**

#### Maintaining the attractive appearance of the brook

- Two brook clean ups November 2013 and March 2014
- Liaison with RiverCare to ensure adequate equipment, insurance, and appropriate risk assessment, and to get general advice
- Supported tree and scrub clearance and willow pollarding, by City the Council

# Raising public awareness about the importance of the brook for wildlife

- Newsletter: 5 issues (numbers 33-37)
- Talk on brook restoration by Cambridge Wildlife Trust at AGM, June 2013
- Display at Cambridge Natural History Conversazione, June 2013

country park for the lakes, provided that this respects wildlife and that access and security issues are fully addressed in the master and management plans (our response document is on the website)

- Continued our collaboration with Sainsbury's who provided volunteers and refreshments for the November clean-up and promoted FCHB work in the entrance to the store. We have met with the manager to discuss plans for improvement of the brook around the store area and keeping it free from the litter which is mainly packaging from the store. The path alongside the store is being swept more frequently, the banks have been cleared and two rubbish bins installed. A third interpretation board, using the design of the other two, will be installed by the store with Sainsbury's covering all the costs.
- With Cambridge Wildlife Trust and City Council wildlife officer, we are starting to develop a proposal to the Heritage Lottery Fund for brook restoration.
- FCHB members resident in Burnside installed swift next boxes on three houses, in collaboration with Action for Swifts

#### Monitoring the wildlife of the brook

- There have been regular sightings of the water vole throughout the year, and we now have a recording system in place; one of the committee members participated in a workshop on voles in April; and RiverCare has loaned us a camera which has been placed at the side of the brook and that will hopefully record picture/videos
- We regularly report on birds and other wildlife in the newsletter

#### Liaison and co-operation with other organisations

- Ongoing communication with Cam Lakes campaign organisers
- Liaison with Cherry Hinton Network and Friends of Cherry Hinton Hall
- We are supporting the Mill Road Local History Project, and will be helping to provide information on the lakes and brook area.

### Friends of Cherry Hinton Brook Accounts for the year ended 31 May 2014
